

Commodity Trading will be conducted either on a daily basis or on the next Selangor Business Day depending on the product type based on Tawarruq as per the following:

| Product Type                            | Trading Day                | Trading Amount                 |
|---|----------------------------|--------------------------------|
| Current Account-i and Savings Account-i | Daily basis                | End-of-day positive balance    |
| Term Deposit-i                          | Next Selangor Business Day | New deposit or renewal balance |

The term "Trading Day" refers to the days when the commodity trading platform is open for trading. Please refer to the announcement of completion of the commodity trading, which is color-coded in light blue, dark blue, and grey. These are performed by the Bank, which acts as an agent for the dates.

## **Current Account-i and Savings Account-i**

The commodity trading will take place on daily basis (including non-business day(s)) based on the amount as at cut-off-time which will be at 11.59 p.m (2359 hours). It will be transacted on the following day ("Commodity Trading"). The Trading Amount will be determined by taking the daily balance of aggregate deposits and withdrawals for the respective day ("Daily Balance"):

- a) If the daily deposit is larger than daily withdrawal, Commodity Trading would be done on the Daily Balance.
- b) If daily withdrawal is the same or larger than daily deposit, the trading amount will be nil; no Commodity Trading will take place.
- c) If there is an increase in the Ceiling Profit Rate (CPR), Commodity Trading would be done on the total account balance based on the new CPR.

## Term Deposit-i

The commodity trading will take place on daily basis (excluding non-business day(s)) based on the amount deposited or renewed. It will be transacted on the following business day ("Commodity Trading").
