<p><b>1. What is this scheme about?</b></p>	
<p>The Public Liability Scheme protects the Participant in respect of his liability to pay compensation for accidental bodily injury or accidental damage to the property of the other person caused by the negligence of the Participant or his employees or by any defects in the premises owned or any defects in the ways, works of the Participant. In addition, the scheme will cover litigation costs and expenses for defense with the written consent of the Takaful Operator.</p>	
<p><b>2. What are the Shariah concepts applicable?</b></p>	
<p>This scheme applies the Shariah concepts of Wakalah and Tabarru'.</p> <p>Wakalah is a contract where the participant appoints the takaful operator to carry out transactions on behalf of the participant to invest and manage the contribution in the General Takaful Fund (hereinafter referred to as "GTF") in accordance with the Shariah. As a return, the participant allows the takaful operator to deduct a certain amount as a wakalah fee for the services rendered.</p> <p>Contribution less wakalah fee will be credited to the GTF as Tabarru' (a.k.a. cost of insurance in conventional insurance).</p> <p>Tabarru' means a donation for the purpose of which is not commercial and is used to help other participants in times of misfortune for the purposes of solidarity, brotherhood and cooperation among participants.</p> <p>Any surplus arising from the GTF will be shared and allocated between the GTF and Takaful Malaysia in accordance with the proportions of:</p> <ul style="list-style-type: none"> <li>(a) 50% of the surplus will be allocated to the GTF, which will be declared and distributed to the eligible participants in the form of Cash Back; and</li> <li>(b) 50% of the surplus will be allocated to Takaful Malaysia.</li> </ul> <p>The surplus arising from the GTF is not guaranteed and will be based on Our actual claims experience and will first be applied to settle any Qardh owing to Us.</p> <p>The entitlement, declaration and amount of Cash Back shall be determined and distributed at Takaful Malaysia's sole and absolute discretion. Cash back (if any) will only be payable to the eligible participants provided no claims have been made and no benefits have been received during the current Period of Takaful.</p>	
<p><b>3. What are the covers / benefits provided?</b></p>	
<p>This scheme covers loss or damage against:</p> <ul style="list-style-type: none"> <li>i) Accidental bodily injury to any person not being a member of the Participant's household or any person in the services or contract of employment with the Participant</li> </ul>	

- ii) Accidental damage to property not belonging to or in the custody or control of the participant
- iii) Any legal expenses incurred by the Participant in defending legal proceedings with the Takaful Operator's written consent.

Duration of cover is for one year. You need to renew your certificate annually.

**4. How much contribution do I have to pay?**

The total annual contribution that you have to pay may vary depending on the risk exposure, sum covered, nature of your business and our underwriting requirements.

Subject to a minimum contribution of RM75.00.

**5. What are the fees and charges that I have to pay?**

**6. What are some of the key terms and conditions that I should be aware of?**

Some of the key terms and conditions that you should be aware of are:

- **Duty of disclosure**

**Consumer Takaful Contract**

Pursuant to Paragraph 5 of Schedule 9 of the Islamic Financial Services Act 2013, if you are applying for this takaful wholly for purposes unrelated to your trade, business or profession, you have a duty to take reasonable care not to make a misrepresentation in answering the questions in the Proposal Form (or when you apply for this takaful). You must answer the questions fully and accurately. Failure to take reasonable care in answering the questions may result in avoidance of your contract of takaful, refusal or reduction of your claim(s), change of terms or termination of your contract of takaful. The above duty of disclosure shall continue until the time your contract of takaful is entered into, varied or renewed with us. In addition to **answering** the questions in the Proposal Form (or when you apply for this takaful), you are required to disclose any other matter that you know to be relevant to our decision in accepting the risks and determining the rates and terms to be applied. You also have a duty to tell us immediately if at any time after your contract of takaful has been entered into, varied or renewed with us any of the information given in the Proposal Form (or when you applied for this takaful) is inaccurate or has changed.

**Non-Consumer Takaful Contract**

Pursuant to Paragraph 4(1) of Schedule 9 of the Islamic Financial Services Act 2013, if you are applying for this takaful for a purpose related to your trade, business or profession, you have a duty to disclose any matter that you know to be relevant to our decision in accepting the risks and determining the rates and terms to be applied and any matter a reasonable person in the circumstances could be expected to know to be relevant, otherwise it may result in avoidance of your contract of takaful, refusal or reduction of your claim(s), change of terms or termination of your contract of takaful. The above duty of disclosure shall continue until the time your contract of takaful is entered into, varied or renewed with us. You also

have a duty to tell us immediately if at any time after your contract of takaful has been entered into, varied or renewed with us any of the information given in the Proposal Form (or when you applied for this takaful) is inaccurate or has changed.

- **Change in Risk** - you must inform the company or your agent in writing of any material changes during the certificate period so that the necessary amendments are endorsed into your certificate.
- **Duty of Participant** - you shall take all reasonable precautions for the safety of the property covered.
- **Excess** - is the first amount of loss that you have to bear in the event of a claim.

#### **7. What are the major exclusions under this scheme?**

This Scheme does not cover certain losses, such as:

- i) Liability in respect of injury or illness to any person in the participant's service or apprenticeship.
- ii) Liability in respect of loss or damage to property belonging to the participant or in charge or control.
- iii) Explosion of steam boiler or vessel operating under steam pressure.
- iv) Loss or damage caused by vibration or weakening and removal of support.
- v) Liability caused by or in connection with or arising from
  - a) Any vehicle, loading and unloading
  - b) Lifts, escalators hoist and cranes
  - c) Defective sanitary arrangement
  - d) Food poisoning
  - e) Fire, flood explosion or water pollution
- vi) Any other events prohibited by Shariah principles

Note:

This list is non-exhaustive. Please refer to the Certificate for the full list of exclusions under this scheme.

#### **8. Can I cancel my certificate?**

You may cancel your certificate at any time by giving a written notice to us. Upon cancellation, you are entitled to a partial refund of the contribution provided you have not made any claim.

#### **9. What do I need to do if there are changes to my contact details?**
