"One of the most important reasons to get the certification is to give them acknowledgement and appreciation for their hard work and dedication as well as proof in attending an entrepreneurial programme. This time around, we are targeting to assist 50 participants." he concluded.

MBSB Bank invested a total of RM818,300 for GRAP 2.0, which will go on for 12 months beginning June 2023.
